

## **SUMMARY ANNUAL REPORT**

### **For PARSONS CORPORATION HEALTH & WELFARE PLAN**

This is a summary of the annual report of the PARSONS CORPORATION HEALTH & WELFARE PLAN, EIN 95-3232481, Plan No. 502, for period 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

PARSONS CORPORATION has committed itself to pay certain self-insured Medical claims incurred under the terms of the plan.

#### **Insurance Information**

The total premiums paid for the plan year ending 12/31/2022 were \$21,342,042.
