There are three paths for veterans filing an appeal with the U.S. Department of Veterans Affairs:



Higher-Level Review

This review is performed by a VA senior reviewer who re-examines your existing record and evidence.



Supplemental Claim

This review is performed by a VA reviewer who evaluates your new and relevant evidence and determines if there is a change in the decision.



Appeals to the Board

If you take this step, you can appeal directly to the Board of Veterans' Appeals, and then you can consider three options.
