

## **SUMMARY ANNUAL REPORT**

### **For Parsons Corporation Health & Welfare Plan**

This is a summary of the annual report of the Parsons Corporation Health & Welfare Plan, EIN 95-3232481, Plan No. 502, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Parsons Corporation has committed itself to pay certain self-insured Medical claims incurred under the terms of the plan.

#### **Insurance Information**

The plan has contracts with Hawaii Medical Service Association, Kaiser Foundation Health Plan Of Colorado, Kaiser Foundation Health Plan Of Georgia, Inc., Kaiser Foundation Health Plan Of The Mid-Atlantic States, Inc., United Behavioral Health dba Optum, Vision Service Plan, MetLife Legal Plans, Delaware American Life Insurance Company, Hartford Accident And Life Insurance Company, Cigna Health And Life Insurance Company, Metropolitan Life Insurance Company, Genworth Life Insurance Company, Lincoln National Life Insurance Company, Kaiser Foundation Health Plan, Inc., and Life Insurance Company Of North America to pay Medical, Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Long Term Care, Business Travel Accident, Legal, Critical Illness, Hospital, Accident, and Tricare Supplement claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$36,480,340.
